

2021 SURVIVOR CONTEST



- 1. All participants must be of legal age in the Province, State or Country of residence. Ontario participants must be 18 years of age or older.
- 2. The official results, as posted by AGCO Judges shall constitute the official and final result for this contest.
- 3. The entrant will endeavour to select the winners of races 1 (one) through the final race. The entrant will select his or her choice of winner, with an alternate choice for each race. In the event that the original selection is scratched, the alternate selection will be deemed to be the new selection for the entrant.
- 4. In the event of a dead heat, all horses in said dead heat for win, place or show shall be deemed to be official winners for the purpose of moving on to the next round.
- 5. Entrant's selection must finish in the top 3 (three) to advance to the next round. If your selection does not finish in the top 3 (three) you will be eliminated from further play.
- 6. The last person(s) alive will be the winner of the contest. The winner shall receive the sum of \$ 100 (one hundred) dollars deposited in their HPI account, if he or she is the sole survivor. In the event of a tie between four or less players, the \$100 (one hundred) dollar prize will be split evenly amongst the winners. In the event of a tie between five or more players, a random draw amongst the five or more tied players will determine the sole survivor, and winner of \$100 (one hundred) dollar prize.
- 7. In the event that the contest winner is not a resident of an HPIBet or the winner does not want to sign up for HPIBet, then they will forfeit their prize and instead be playing for pride.
- 8. The contest will run from race to race until all contestants are eliminated or the final race has been run, whichever comes first.
- 9. All staff of Grand River Raceway and/or Grand River Agricultural Society are NOT eligible to participate.
- 10. All entries must be received before 6:15 PM on each Wednesday that the contest is held. Entries can be made online at www.grandriverraceway.com.
- 11. Only one entry per person, per race day.
- 12. Contest winners agree to allow Grand River Raceway to use their name and image in respect to any promotional or media release concerning the contest.
- 13. Incomplete entries will be considered null and void.

- 15. Winning contestants will be asked a skill testing question before the prize is awarded.
